## **About Yarra Energy Foundation**

Yarra Energy Foundation (YEF) is an independent, for-purpose organisation with a huge ambition – to achieve a zero carbon future in the City of Yarra. YEF exists to engage and inspire people who live and do business in the City of Yarra to take practical steps towards this goal. Established by Yarra City Council in 2010, YEF receives critical core funding support from the Council and is governed by an independent board of highly skilled and experienced professionals.

## **Our Community**

The City of Yarra is primarily young, single, educated, and affluent, with the largest age group being 25-29 year olds, followed by 30-34 year olds. However, Yarra has a significant population of vulnerable residents. 10.8% of residents live in social housing, 18% of households are considered low income, and 24% are over the age of 50. Yarra is culturally diverse, with 23% of residents coming from non-English speaking backgrounds. The City of Yarra's annual community-wide emissions are approximately 1.94 million tCO2-e (latest available data 2018/19).

## **Our Vision**

Yarra as a vibrant, zero carbon community that is diverse, participatory and sustainable. Businesses, homes, schools, community facilities, our transport and waste systems are efficient and effective and have a positive impact on the environment. People care about and contribute to their community and the local environment.

## **Our Purpose**

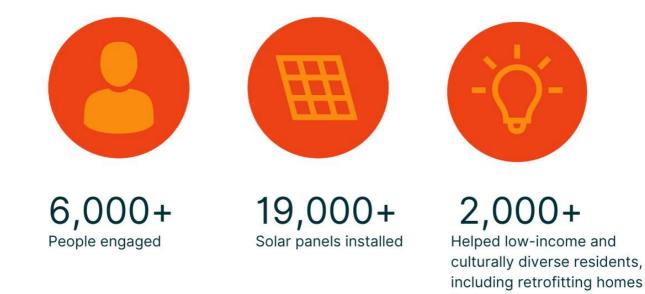

## This Year In Review

#### Community Engagement

- 180+ residents attended our Yarra Solar & Battery Information Sessions
- 80+ low-income & CALD residents attending 8 energy literacy workshops via Neighbourhood Houses and Carringbush Women's Group
- 160+ phone consultations with residents and businesses

- Emissions reduction from residential solar PV (Yarra only): 633 tCO2-e / 15,825 tCO2-e over 25 years
- Emissions reduction from commercial solar PV: 333 tCO2-e / 8,396 tCO2-e over 25 years

#### Impacts of COVID-19 and Funding

Program results have been severely impacted due to the COVID-19 pandemic, especially in the second and third quarters of FY 2019/2020. Despite this, YEF secured additional funding of \$69,994 in consulting and sales (more than twice YEF's 5% minimum requirement of \$33,500).
